Short and Long-Term Projects

Company of Nepalese Investors Limited (CONIL-Investment) is actively exploring investment opportunities across various sectors that align with our objectives of sustainable growth, innovation, and collective prosperity.

As our first project, we are participating in an Eco-Village Project covering 75 ropani of land in Kavreplanchowk District, as part of a larger 1,200 ropani development. The project is founded on the principles of low-cost housing, community-based living, and sustainable agriculture through modern horticulture farming, fish farming, animal breeding, and poultry farming. Additionally, the project will include the construction of a seminar room, conference hall, resort, wellness center, and homestay facilities to enhance its touristic value.

CONIL-Investment is actively working on a landmark project in Sindhupalchowk District, encompassing approximately 1,000 ropani of land, to establish a Coffee Plantation and Eco-Village. The project is based on the principles of low-cost housing, community-based living, and sustainable agriculture through modern horticulture farming, fish farming, animal breeding, and poultry, as well as tea plantation and production in llam. To scale this model, CONIL-Investment plans to sign Memorandums of Understanding (MoUs) with local governments and community organizations across Nepal to jointly develop eco-villages equipped with modern infrastructure and essential facilities. The goal is to promote affordable housing, enhance rural livelihoods, and reduce internal migration by building self-reliant and sustainable rural economies.
